## 1. LEVEL OF SUBSCRIPTION OF PUBLIC BALLOTING AND PLACEMENT

#### (a) Public balloting

A total of 10,050 applications for 601,644,700 Issue Shares were received from the Malaysian Public for 22,800,000 Issue Shares made available for application by the Malaysian Public, which represents a total oversubscription rate of 25.39 times. 11,400,000 Issue Shares have been set aside for allotment for the Bumiputera portion, which represents 50% of the Issue Shares available for public subscription, while the remaining 11,400,000 Issue Shares were allotted under the public portion.

For the Bumiputera portion, a total of 5,103 applications for 201,562,700 Issue Shares were received, which represents an oversubscription rate of 16.68 times. For the public portion, a total of 4,947 applications for 400,082,000 Issue Shares were received, which represents an oversubscription rate of 34.09 times.

The 12,500,000 Issue Shares reserved for application by the eligible Directors and employees as well as persons who have contributed to the success of LGMS Group have been fully subscribed.

#### (b) Private placement

A total of 57,000,000 IPO Shares (comprising 11,400,000 Issue Shares and 45,600,000 Offer Shares) were made available by way of private placement to identified Bumiputera Investors, whereby an aggregate of 45,045,300 IPO Shares were subscribed by 953 Bumiputera Investors. Pursuant to the terms of the Prospectus, the balance of 11,954,700 IPO Shares were clawed back and reallocated by way of private placement to the identified institutional investors.

In addition, the 44,695,000 Issue Shares made available by way of private placement to identified institutional and/or selected investors have been fully placed out.
